## MINUTES OF THE MEETING OF GOSFORD JUNIOR CRICKET CLUB

### Minutes from Previous Meeting – TS:

Status of action items from previous meetings:

- Rego completed by entire committee on 23/9 and 30/9. A big thank you to everyone for helping out.
- TS completing sponsorship letters and in particular, chase up Phil Conacher about sponsorship again this season.
- AS contacted Jeff Hall and engaged him to reconstruct website. Agreed that we would use the domain name “gosfordcricketclub.com” due to previous domain being unavailable.
- TS to chase up \$250 ground hire fee for Victoria Park.
- HT to chase up Woolworths grant for next season. Current grant cycle closed in April.
- HT downloaded Telstra sponsorship forms. TS to review and fill in over coming month.
- DA chased up Bunnings BBQ and advised we had been allocated Sunday 1<sup>st</sup> March, 2009. Committee to organise closer to date.
- Mike Lipscombe agreed to take Kanga for upcoming season. Will be held on Tuesdays and commence 4<sup>th</sup> November. TS to liaise with ML re organising same (i.e. player lists and rego, equipment, note to parents and registration with Cricket NSW).

### Secretary’s Report – TS:

- Correspondence In:
  - E-mails from CCJCA re minutes of CCJCA meeting and Competition and Grounds Sub- Committee.
  - Team nomination from CCJCA. TS forwarded to BY for response once numbers determined on at extraordinary meeting on 16/9/08.
  - Ball orders to be done through Waratah Sport or Jamie O’Donnell. CS to determine number and type of ball (as per requirements of CCJCA). Leather ball for Under 15/16’s. Terry Oval costs & vacant positions on committee.
  - E-mail from CCJCA agreeing to provide \$3,000 assistance for upgrading of Terry Oval pitch given higher quote and shortfall in grant to cover. TS agreed to chase up amended quote from Playcover and additional quotes from other companies and Council, as well as possibility of further funding from Gosford Council. TS also to follow up possible need for another ground with Jamie O’Donnell (CCJCA) if Terry Oval not ready in time and given poor quality of Adcock 3.
- Correspondence out:
  - Letter to CCJCA requesting funding assistance for Terry Oval given higher quote.
  - E-mails to CCJCA responding to their e-mails as necessary.
- Terry Oval Pitch
  - Discussed in correspondence above.

### CCJCA Delegates Report – CW

- Cricket NSW – Club Assistance package tabled.
- Level 1 Coaching course – Wednesday 10<sup>th</sup>, 17<sup>th</sup> and 25<sup>th</sup> September. Level 0 is pre-requisite. CS advised club will pay for coaches to do course.
- Ball orders required by end of August (already passed). Unrealistic. CS to chase up with Waratah Sports.
- CD of templates (forms, standard letters etc) available from CCJCA. Not provided to club - CW to chase up.
- CCJCA short of official umpies. Paid job – looking for interested parties.
- Sue Inwood new Women’s Cricket associate delegate. Asked we forward any names of girl cricketers to her. CW to pass on Emily Talty at next meeting.
- Team Nominations to be provided by 18 September. Extraordinary meeting to be undertaken on 16<sup>th</sup> September at CCLC to confirm final team numbers and players and coaches for each.
- Next meeting 10/9/08.

### **Treasurer's Report – AS**

- AS unable to attend. Statement tabled. Sponsorship from Bendigo Bank of \$2,200 deposited plus interest re-invested. Current balance approximately \$17,500.
